

**ORDINANCE NO. 89**

**AN ORDINANCE TO AMEND ORDINANCE NO. 24;  
TO REPEAL ORDINANCE NO. 43 WHICH AMENDED ORDINANCE NO. 24;  
AND TO DECLARE AN EMERGENCY AND FOR OTHER PURPOSES**

WHEREAS, the City Council of the City of Goshen adopted Ordinance 24 on November 12, 2002 and thereby created certain procedures regarding the proceedings of the city Council of the City of Goshen; and

WHEREAS, the City Council of the City of Goshen adopted Ordinance No. 43 on March 9, 2004, which amended Ordinance No. 24; and

WHEREAS, the City Council finds that the public places within the City where the ordinances are posted should be changed due to the closing of the One Stop Mart #2 which had been designated as one of the five.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL FOR THE CITY OF GOSHEN, ARKANSAS:

SECTION 1. That Ordinance 43 is hereby repealed in its entirety and Ordinance 24 is amended to delete Section 3 and that the following language shall be substituted as Section 3 of Ordinance 24:

That the City Recorder shall compose the agenda of regular meeting of the City Council and cause it to be posted in the five most public places within the City where the City posts ordinances after their adoption, which places are City Hall/Fire Station, Community Bank, Fast Trax, Thrift Shop, and the Post Office. This shall be done no later than 5 p.m. Thursday preceding the regular meeting on the following Tuesday.

SECTION 2. The intended effect of this ordinance is to change the public places within the City where the ordinances are posted. In all other respects, Ordinances 24 is ratified and reaffirmed.

SECTION 3. EMERGENCY CLAUSE: It is hereby declared that based on the conditions set forth herein, an emergency exists and this Ordinance, being necessary for the immediate protection of the health, safety, and welfare of the citizens of Goshen, Arkansas, shall be in effect immediately upon its passage, approval, and publication.


