I, Sharon Baggett, certify that I am the Recorder for the City of Goshen; that I am the person authorized to certify documents from the official records of the City of Goshen; that on March 6, 2018 at a special called meeting of the City Council of Goshen, the attached Ordinance No. 147 was presented as required by statute; that the Ordinance was adopted on March 6, 2018 by motion properly made and duly seconded, by a majority vote of the aldermen of the Goshen City Council, as duly noted at the end of the Ordinance; that on March 7, 2017, the Ordinance was posted in five public places within the City of Goshen, consistent with the ordinances of the City of Goshen and state law; that this Ordinance levies a 1% sales and use tax within the City of Goshen; that this Ordinance shall not take effect until an election is held on the question of levying the Sales and Use Tax at which a majority of the electors voting on the question shall have approved the levy of the Sales and Use Tax; that once the election is held, the results of the election shall be proclaimed by the Mayor, and the Proclamation shall be published one time in a newspaper having a general circulation in the City, which Proclamation shall advise that the results as proclaimed shall be conclusive unless attacked in the courts within thirty days after the date of publication; and that said Ordinance, having been properly adopted, is officially part of the records of the City of Goshen.
